**ABILITY TO BENEFIT TESTING DATES**

Dear Student:

In your recent application for financial aid at Cuesta College, you indicated that you were not a High School graduate or the equivalent. For periods of enrollment beginning on or after July 1, 1991, the law requires that a student, who lacks a high school diploma, or the equivalent, must pass an independently administered test approved by the Secretary of Education in order to receive Title IV student financial aid. Therefore, before receiving federal education funding, any student without a high school diploma must "pass" this test.

***If you have a high school diploma, GED, or Certificate of High School Proficiency, or will have one by June 2009, please submit a written statement with your name, Social Security number and signature to the Financial Aid Office.***

This campus wants to work with you to overcome this additional hurdle. Cuesta College administers the Ability to Benefit Test called the Wonderlic Basic Skills Test. The test is given on a monthly basis.

Contact the Assessment Office at (805) 546-3100 extension 3951 as soon as possible to schedule a testing date or go to the Assessment Office in the 3400 building, 2<sup>nd</sup> floor of the San Luis Obispo Campus and sign up.
